<u>Product description:</u> ElastoSeal EPDM is a non-reinforced EPDM geomembrane that remains elastic regardless of age and temperature. It is known to provide excellent weatherability and has a high resistance to root penetration (EN 13948). It is not exposed to "stress cracking", and does not have a yield strength like thermoplastic materials. ElastoSeal EPDM can be installed exposed or covered with soil or water. It has a good ability to withstand mechanical impact from pressure or movement. Seams between ElastoSeal membranes can be made with a specially formulated hot splice technique, called Thermobond.





Manufacturing:

First the compound from the supplier is run through a calendar machine, to get the right dimension on the order. Uncured scrap is recycled immediately and processed again through the extruder.

Thickness is continuously controlled during calendring

Secondly the product is moved to the vulcanisation furnaces. The process involves the formation of cross-links between long rubber molecules to achieve improved elasticity, resilience, tensile strength, viscosity, hardness and weather resistance. The vulcanised sheets are run through an inspection station and then are packed according to specific customer order.

ElastoSeal EPDM has a very good resistance against UV and ozone. EPDM has no yield point, which makes is very suitable for geo applications. The membrane remains flexible at all times and can withstand mechanical stresses that are common for this application

ElastoSeal can be used in both cold and hot environments, from the north to the south of Europe, thanks to its cold bending properties below -40°C and to a temperature resistance up to 120°C, without significant change to the flexibility of the membrane. The waterproofing membrane has a life expectancy of more than 50 years. This test was performed by SKZ in 2004.
